This AMENDMENT to the Restated Covenants, Conditions and Restrictions which was recorded in Crook County, Oregon Deed Records on September 14, 2001 as Microfilm #165315, hereinafter referred to as "CC&R's", is made by all the owners of the lots comprising the WEST POWELL BUTTE ESTATES SUBDIVISION in Crook County, Oregon, as follows:

- 1. To add to Section 4.7 of the Restated Covenants, Conditions and Restrictions for West Powell Butte Estates new subsections (j) and (k) to read as follows:
 - (j) No mobile homes, manufactured homes or other pre-fabricated homes of any type or nature shall be erected, placed or permitted on any lot in the development.
 - (k) No buildings shall be constructed within 100 feet of any lot line, except where such lot line is separating the lot from Bureau of Land Management or other public land.
 - 2. To add to Article VII a new Section 7.11 to read as follows:
 - 7.11 Amendment. The Restated Declaration of Covenants, Conditions and Restrictions for West Powell Butte Estates and all amendments thereof may be amended by the vote or consent of owners owning not less than seventy-five percent (75%) of the lots in the West Powell Butte Estates subdivision.
